Objectives/End of Year Status:

- 1. Continue the speaker series. Status: Accomplished (see activities below).
- 2. Grow the Chapter regular membership. Status: Regular membership numbers increased from 86 to 107. All alumni, whether Chapter members or not, are invited to all activities/events.
- 3. Continue/enhance our support of the Semper Fi Fund and Quantico National Cemetery. A check was presented in May to the Semper Fi Fund for \$750 covering the speaker appreciation gifts to each speaker over the past three years.



QAC also supported the Quantico National Cemetery efforts. Members, family and friends participated in laying wreaths on headstones in December (part of the Sgt Mac effort) and raising flags along the roadsides of the cemetery in preparation for Memorial Day.

- 4. Support Congressman Wittman's Academy Candidates Evaluation Board. Ten members of the Chapter supported the candidate interview process by sitting on boards over several weekends. The Chapter also volunteer the same support to Rep Gerry Connolly (D-VA). His staff did not need our support this past year but we will be offering that support again in the Fall of 2018.
- 5. Vibrant support of STEM. Continued to search for ideas on how to get more involved. Our STEM coordinator work diligently with the USNA STEM coordinators but we were unable to find anything we could help them with. It appears that our geographic area is well endowed with STEM support and backing.
- 6. Vibrant support of our BGO. Continued to offer support for the BGOs in our area. Our BGO is well aware of the Chapter's willingness to help but did not need to call upon us this year. He has available to him a "quick reaction" list of Chapter Members delineating who served in what Service, what their Specialty was, etc. This will allow the BGO to put a prospective candidate, who has a

specific interest in an area (e.g. Carrier Aviation), with a Chapter Member who served or serves in that Specialty.

7. Develop a Chapter Crest. Completed. We worked to develop the Crest in order to better brand and identify our Chapter. We had significant help from the Leadership and Graphic Artists at USNAAA to smooth our desired pattern and we much appreciate that help.



Chapter Events

6 Jun 17: The first Council meeting of the new term was convened with nine of ten Council members present, along with the BGO and STEM representatives and one past President. The new President went over duties and responsibilities of the Council members, along with ideas on how to add to those responsibilities based upon the experiences of the past five years. Committee members for the various committees were decided upon. Ideas of things to be done this year, along with the goals of the Chapter were discussed. Members did give him some grief about being from USMA and running a maritime museum, but he took it gracefully and presented a well thought-out discourse on what he is trying to accomplish. 13 Oct 17: Monthly breakfast guest speaker VADM Thomas J. Moore '81 USN, currently Commander of the Naval Sea Systems Command (NAVSEA). VADM Moore spoke on the responsibilities of NAVSEA and some of the actions being taken to ensure American seapower is maximized and technically up to date with rapidly changing technology. VADM Moore also answered several questions from attendees. He was our 'guest of honor' for a ceremony honoring the 242nd birthday of the United States Navy and Founders Day, and cut the cake with the oldest (Bob Dulin '61) and youngest (LT Praveen Murthy '12) Navy alumni receiving the first pieces. 26 Oct 17: Company E TBS Combat Arms MOS Mixer from 1600-1900.

Oct-Nov 17: Several members served on Congressman Wittman's evaluation boards for determining his nominations for the coming year. These boards were convened on Saturday mornings over several weeks.

3 Nov 17: Monthly breakfast guest speaker MajGen Kevin liams '86 USMC, Commander of Marine Corps Training and Education Command (TECOM). Maj Gen liams spoke to the continuing evaluation and improvement to Marine training, from Boot Camp on up. There are some very interesting initiatives taking place in order to facilitate training for the 'new generation' of Marines. MajGen liams also answered several questions from attendees. He was our 'guest of honor' for a short ceremony honoring the 242nd birthday of the United States Marine Corps during which CMC's birthday video was shown and Gen LeJeune's message read, along with all singing the first verse of the Marine Corps Hymn. 1 Dec 17: Monthly breakfast guest speaker, Mr. Kevin Burton from the FBI's Behavioral Analysis Unit and Cyber Behavioral Analysis Center. Mr. Burton, a former Marine and NYPD police officer, briefed us on his duties and the challenges the FBI faces on a daily basis. The approach used when profiling people accused on crimes is to connect with the accused in a way that leads to finding out what he/she is really like. Cultural awareness is also investigated and used in the profiling effort. The last resort used is the 'hard' approach during which most accused stop talking. The goal is to find out why something happened and not just the details of the crime. Keven was sponsored by QAC member Joe Bertoldi '90, also with the FBI. Held at the Holiday Inn in Dumfries, VA. 2 Dec 17: Several members participated in a Wreath Laying Ceremony at Quantico National Cemetery, put on by the Sgt. Mac Foundation.

- 6 Dec 17: The third Council meeting of the current term was convened with a 9 present. Committee members and Council members updated status for a variety of topics. The results of the vote for the design of the new QAC logo were announced. Held at Fatty's Tap House in Stafford, VA.
- 6 Dec 17: Article published in the Nov-Dec 2017 Shipmate.
- 6-7 Dec 17: Bob Sonnenberg attended the Board of Trustees meeting in Annapolis. Bob Taylor also attended the full BoT meeting on 7 Dec. He was able to meet with Joe Fagan regarding assistance to develop the new logo.
- 9 Dec 17: The Chapter funded an Army/Navy gathering at The Basic School for all lieutenants. Drinks and food were provided. Many of the current lieutenants are USNA grads from 2017. In attendance were 20 Chapter members/spouses with approximately 120 TBS lieutenants. A great event!
- 12 Dec 17: The President signed the National Defense Authorization Act into law. There was language included that allowed the Navy to lease the land proposed for the new USNA Alumni Building across the street (king George) from the baseball stadium. The lease will be for 50 years with one renewal period of 50 years. This was an important and needed step to allow the effort to go forward.
- 5 Jan 18: Monthly breakfast guest speaker, VADM Paul Grosklags '82 USN, currently Naval Air Systems (NAVAIR). Admiral Grosklags gave a very interesting presentation concerning the current readiness levels of Navy and Marine aircraft and spoke to the challenges he faces on a daily basis. His analysis of where the Navy/Marine Corps could improve readiness by changing the 'system' that has been in place his entire 35-year career was well received. He readily answered numerous questions from those in attendance and said that he appreciated speaking to groups large and small as many in attendance would always give him new ideas and perspectives to consider. She is the founder and executive director of Postpartum Support Virginia and has provided information and support to new mothers experiencing postpartum depression since 2005. Adrienne holds a Masters in Public Policy from Harvard's Kennedy School of Government. Her military career as an intelligence officer included assignments with VP-11 in Brunswick ME, with the Office of Naval Intelligence in the Pentagon, and with the National Security Council at the White House. She also worked for the United Nations mission to Somalia during that country's civil war in the early 1990s and as the Assistant to the Commission of the IRS. Adrienne lives in Arlington VA with her husband and three children. She gave a very heartfelt talk about her life and experiences to those in attendance, and engaged in some discussion afterwards. The audience found that Postpartum Depression is very similar to PTSD, and some comments on resolving those issues were discussed. She received a standing ovation. Held at the Holiday Inn in Dumfries, VA. Attendance: 32
- 23 Feb 18: Several members participated in the MAGTF mixer for Fox Company at TBS.
- 2 Mar 18: Monthly breakfast with guest speaker BGen Scott Benedict '90, USMC and QAC member in good standing, currently Director of Manpower and Reserve Affairs at HQMC in Quantico, VA. BGen

Benedict gave a very welcome overview of where the Corps stands now and some of the challenges it faces in the future. After his presentation, he readily answered many questions from the audience. Held at the Holiday Inn in Dumfries, VA. Attendance: 21 (severe wind storm kept many away).
